Lawful purpose- The Trust has been created for any lawful purpose. The purpose of a trust is lawful unless it is

(a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the Court regards it as immoral or opposed to public policy. Every trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is lawful and the other unlawful, and the two purposes cannot be separated, the whole trust is void At present The Trust has Minimum 2 Settlers & Minimum 2 Trustees.

2. SETTLEMENT

The Party of the First Part, the Settlers in pursuance of the common intention as stated hereinbefore, does hereby settle a sum of Rs. 10,000/- (Rupees Ten Thousand only) each, aggregating to a sum of Rs. 20,000/(Rs. Twenty Thousand only) by cash unto and in favour of the Trustees herein to be held by them for and on behalf of the Trust hereby created and known as "**KANHAIYALAL MAHADEVI SINGHAL FOUNDATION**" (A Non Profitable Non Commercial Public Charitable Trust) the receipt of which, is hereby acknowledged by the Trustees, who hereby accept the appointment as such Trustees of the said Trust, under the terms and conditions, set out hereunder for the fulfillment of the objects of the Trust, more fully and particularly described and set out hereinafter.

Function of trust :

3. NAME & DATE OF COMMENCEMENT OF THE TRUST :

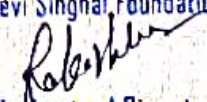

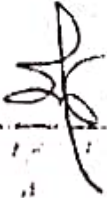
10. POWER OF TRUSTEES :

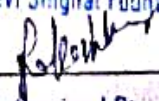

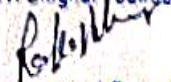
Without prejudice to the scope and generality of the powers and authority conferred upon the Trustee under The Indian Trusts Act, 1882 the Trustee shall be competent to contract and act as legal/ beneficial owner of such property, and such powers shall not be restricted by any principle of construction or rule or requirement, but shall operate according to the widest generality of which the foregoing words are capable, notwithstanding that certain powers are more specifically set forth herein.

11. BOARD OF TRUSTEES :

11.1 The Trust will be managed by a Board of Trustees consisting of at least one trustee nominated by each of the Settlers. The number of Trustees in the Board of Trustees shall not be less than two Trustees and not more than ten or such higher number as may be decided by the Board of Trustees. If the number of Trustees falls below two, the remaining Trustee shall not, except for the purposes of filling any vacancy, act so long as number is below the said minimum.

11.2 The Settlers shall have right to nominate additional trustees in proportion (rounded off to the nearest whole number) to the contribution made by each of the Settlers in Trust Fund in the previous financial year.

11.3 Trustees nominated by the Settlers in the Board of Trustees cannot be removed till death/incapacity unless removed by the Settlers

11.4 The Trustee may resign from his/her trusteeship hereof by giving one calendar month notice in writing of his or her intention to do so to the Board of Trustees and after the expiry of the period of notice ; such Trustee giving the notice shall ipso facto cease to be a Trustee of the Trust.

11.5 If any Trustee dies or retires or becomes incapable or unfit to act, A new Trustee to fill the vacancy caused by him/ her will be appointed from his family members or a person nominated by his family members with the consent of the continuing or surviving Trustee or Trustees.

11.6 Upon the appointment of a new Trustee, duties and power of the Trustees set out in this Deed shall vest in the new trustee jointly with the continuing or surviving Trustees.

11.7 The office of a Trustee will automatically become vacant on the occurrence of any of the following events;

- 11.7.1 extinction of the Trust;
- 11.7.2 death;
- 11.7.3 bankruptcy;
